Jena Baker-Calloway

Jena Baker-Calloway is a dedicated higher education center administrator at Michigan State University with extensive experience in public health, community partnership development, and pre-college programs. She serves as the director of the MSU Detroit Center, a department of University Outreach and Engagement located on Woodward Avenue in the heart of Detroit.

With a strong foundation in public health, Calloway has worked to enhance the well-being of campus communities through strategic initiatives that promote health education and access. She excels in building and fostering partnerships between educational institutions and local organizations, ensuring collaborative efforts to support students and their broader communities. Having led numerous pre-college programs, she is committed to creating pathways for underserved students to achieve academic success.

Calloway also oversees facility operations, ensuring that learning environments are safe, sustainable, and conducive to student success. Passionate about equity and student support, she continues to make a meaningful impact on higher education.

Amy DeRogatis

Amy DeRogatis is chair and a professor of religion and American culture in the Department of Religious Studies at Michigan State University. DeRogatis' research focuses on the multiple ways that religious groups, people, and communities in North America express religious ideas, commitments, beliefs, and knowledge through embodied practices.

In Saving Sex: Sexuality and Salvation in American Evangelicalism (Oxford, 2013), she delved into the history of popular evangelical sex manuals and the efforts that authors made to convince readers that embodied sexual practices and restraints constitute a form of witnessing to their faith. Her first book, Moral Geography: Maps, Missionaries, and the American Frontier (Columbia University Press, 2003), employed cultural geography and spatial theory to examine white Protestant missionary efforts to shape the space of 19th-century northeastern Ohio. Drawing on an archive of letters, diaries, publications, and maps from the Connecticut Missionary Society, she argued that missionaries found evidence for their success by inscribing their moral values onto the physical landscape. DeRogatis is at work on a third book, Mormon King, about James Jesse Strang and the 19th-century Mormon community on Beaver Island, Michigan.

DeRogatis also co-directs the American Religious Sounds Project, a collaborative 10-year digital initiative, supported by the Henry Luce Foundation, to document and interpret the diversity of American religious life by attending to its varied sonic cultures. DeRogatis has received recognition for teaching excellence and is the recipient of the William J. Beal Outstanding Faculty Award.

Mohammad Hassan Khalil

Mohammad Hassan Khalil is a professor of religious studies, an adjunct professor of law, and director of the Muslim Studies Program at Michigan State University. Before returning to his hometown of East Lansing, Michigan, he was an assistant professor of religion and visiting professor of law at the University of Illinois at Urbana-Champaign.

He specializes in Islamic thought and is author of *Islam and the Fate of Others: The Salvation Question* (Oxford University Press, 2012) and *Jihad, Radicalism, and the New Atheism* (Cambridge University Press, 2017); and editor of *Between Heaven and Hell: Islam, Salvation, and the Fate of Others* (Oxford University Press, 2013) and *Muslims and US Politics Today: A Defining Moment* (ILEX and Harvard University Press, 2019). He is also the lead investigator of the Muslims of the Midwest digital archive (muslimsofthemidwest.org); co-producer, co-director, and co-writer of the documentary film *American Jedi: The Salman Hamdani Story* (Alexander Street, 2023); and co-PI of a project funded by Templeton Religion Trust entitled "Science, Art and Faith: Architectural Heritage and Islam."

He has presented papers at various national and international conferences and has published peer-reviewed journal articles and book chapters on various topics, from early Islamic historiography to bioethics. He is the recipient of multiple awards, including, most recently, the William J. Beal Outstanding Faculty Award, which recognizes excellence across the mission of the university.

Gretel Van Wieren

Gretel Van Wieren is a professor of religious studies and affiliated professor of philosophy at Michigan State University, where her research and teaching explore the spiritual and moral dimensions of people's relationship to land.

She is the author of the books Listening at Lookout Creek: Nature in Spiritual Practice (Oregon State University Press, 2019); Food, Farming and Religion: Emerging Ethical Perspectives (Routledge, 2018); and Restored to Earth: Christianity, Environmental Ethics, and Ecological Restoration (Georgetown University Press, 2013), as well as numerous articles and popular essays that have appeared in publications such as Environmental Ethics; Conservation Biology; the Journal for the Study of Religion, Nature, and Culture; the Public Philosophy Journal; Worldviews: Global Religions, Culture, and Ecology; and the Center for Humans & Nature City Creatures blog.

Van Wieren founded the New Ethics of Food Network and is a founding member of the Restoration Ecology Global Education Network and the Blue River Quorum. She received a 2016 Mellon Foundation/Humanities Without Walls grant on the New Ethics of Food, a 2022-23 Cedar Creek Ecosystem Science Reserve Artist-in-Residence award, and a 2015 H.J. Andrews Experimental Forest Writing-Residency award. She co-leads the artist-in-residence program at MSU's Kellogg Biological Station and MSU's Religious Studies program in Nonprofit Leadership, Global Cultures, and Social Enterprise. Van Wieren received a Master of Professional Studies in international development from Cornell University and an M.Div. and Ph.D. in religious studies from Yale University.

Megan Halpern

Megan K. Halpern is the founder and director of MSU's Center for Interdisciplinary Research, Collaboration, Learning, and Engagement (CIRCLE) and an associate professor of science and society in Lyman Briggs College, where she also currently serves as a Leadership Fellow in Faculty Affairs.

Halpern's research and teaching interests include art-science studies, interdisciplinary collaboration, public engagement with science, and feminist approaches to science communication. She draws heavily on arts and design methodologies in her research, teaching, and practice. She is known for the *Handbook of Art, Science, and Technology Studies*, which launched a new field of study into the intersection of art, science, and technology, and for her work on the experience model of science communication.

Halpern graduated from Smith College in 1997 with a bachelor's degree in studio art. She worked as a freelance set designer and scenic artist in New York City, where, in 1999, she co-founded Redshift Productions to create performances inspired by science and in collaboration with scientists. Her experience facilitating art-science collaborations with Redshift inspired her to attend Cornell University, where she earned a doctorate in science communication in 2014.

Upon graduating from Cornell, Halpern began a postdoctoral research fellowship at Arizona State University's Center for Nanotechnology and Society and Center for Science and the Imagination, where she began to develop Future Design Studio, a speculative design and improvisation workshop on the politics of artifacts. She joined Lyman Briggs College in 2015.

Excellence Award for Interdisciplinary Scholarship

MSU Telehealth Research Group

The MSU Telehealth Research Group, led by Sabrina Ford, Kelly Hirko, and Bree Holtz, exemplifies interdisciplinary collaboration in advancing telehealth research, education, and policy. Integrating expertise in health communication, epidemiology, and community-based interventions, the team focuses on expanding access to health care, particularly in rural and underserved communities.

Their collaboration began in 2019 through a National Science Foundation initiative on rural broadband. While that project was not funded, it catalyzed a long-term partnership that led to securing an MSU Science and Society at State (S3) Interdisciplinary Seed Grant. This funding supported a pilot study on telehealth adoption in three rural Michigan communities, laying the foundation for future research and funding. Since then, the team has launched multiple initiatives, including the development of a telehealth curriculum for medical students and rural health care providers through a Michigan Health Endowment Fund grant, utilizing a "train-the-trainer" model to enhance telehealth literacy and delivery. They also secured an AHRQ R13 Grant to host "Telehealth Post-Pandemic: A Roadmap for the Coming Decade," a national conference that brought together experts to establish best practices and policy recommendations for telehealth sustainability.

Beyond Michigan, their research has extended globally, including studies on telehealth implementation in Uganda, highlighting barriers to equitable health care access. Their work has influenced health care education, rural medicine, and national policy, directly benefiting underserved populations. Collaborating with MSU's partners, industry leaders, and state agencies, the team has published extensively in high-impact journals. Their sustained commitment to interdisciplinary collaboration ensures continued leadership in shaping the future of telehealth.

Grant Bruninga is a fourth-year student at Michigan State University majoring in zoology and integrative biology with a minor in environmental and sustainability studies. As a research assistant, he has coupled his lifelong passion for fish and wildlife conservation with his interests in genetics and environmental policy. In addition, Bruninga was a Conservation Science Fellow studying California mountain lions with the San Diego Zoo Wildlife Alliance and assisted in field research as part of a wildlife conservation study abroad in South Africa.

Currently, he serves as an undergraduate research ambassador and volunteers with Honors Students Actively Recruiting (H-STAR) to help recruit the next generation of Spartans and get them involved in research. Bruninga is deciding between University of California – Davis, University of British Columbia, and Illinois State University to pursue a master's degree in ecology. In the future, he hopes to be a professor and lead a research team that uses an interdisciplinary approach, combining conservation science with community-based policy to protect global ecosystems from ongoing threats of climate change and habitat degradation.

Maryam Berijanian is a doctoral student specializing in generative AI, computer vision, and natural language processing. She has achieved a 4.0 GPA and received several prestigious recognitions, including the Engineering Distinguished Scholar Fellowship from MSU. In 2024, Maryam achieved second place in the IEEE WIE Global Tech Marathon and was recognized for Best Originality/Creativity in the Advanced Category at the AI Hackathon organized by ACCESS Support (NSF).

She holds dual bachelor's degrees in mechanical and aerospace engineering, as well as a master's in robotics and mechatronics. Before joining MSU, she was a researcher at RWTH Aachen University in Germany, where she focused on computer vision and deep learning.

Berijanian will be using funds from the Phi Kappa Phi Love of Learning Award to attend a conference in the AI or technology field, such as Association for the Advancement of Artificial Intelligence or Grace Hopper, which can be greatly beneficial for her professional and career development.
