Bethany Judge

Bethany Judge is the assistant dean for Undergraduate Student Affairs & Study Abroad in the College of Arts and Letters at Michigan State University. The College of Arts and Letters houses the humanities, visual and theatre arts, as well as innovative programs in arts and cultural management, digital humanities, and user experience at MSU. As the assistant dean, she is responsible for undergraduate initiatives that directly impact students such as the freshman year experience course in the college, experiential learning initiatives including undergraduate research and internships, and many programs designed to increase retention and graduation rates. Assistant Dean Judge has played an integral role in creating the Citizen Scholars program in the college, as well as the Excel Network, which focuses on career and professional development in the college and integrating experiential learning into student degree programs, which she oversees. In addition to this work, Assistant Dean Judge also oversees the academic components of more than 75 study abroad programs offered through the college. She has worked with colleagues to develop 13 internship programs in locations around the globe. She has a BA in International Relations from Michigan State University, a JD from the University of Detroit, and an MA and is ABD with a PhD in International Studies with concentrations in political development and human rights.

Miles McNall

Miles McNall, Ph.D., is the director of the Community Evaluation and Research Collaborative (CERC) at Michigan State University. Miles has 19 years of experience with the evaluation of health and human service programs. He coordinated the evaluation of HIV prevention programs for young men at the University of Minnesota Medical College and guided the development of client outcome monitoring systems for agency programs at Catholic Charities of Chicago. At the CORE Center in Chicago, he evaluated HIV/AIDS care and substance abuse treatment programs and coordinated the agency's healthcare quality improvement efforts. Since joining the faculty at MSU, Miles and his colleagues have conducted evaluations of comprehensive community initiatives, school-based health centers, and intensive home-based treatment services for children with severe emotional disturbances. More recently, Miles has been involved in the evaluation of systems change initiatives, including efforts to transform early childhood and youth mental health systems in several Michigan communities. Miles has been a member of the Michigan Association for Evaluation (MAE) since 2006 and joined the MAE board in 2010. While working with communities to resolve complex problems, Miles became interested in participatory systems modeling because he believed that this approach offered

methods that enable diverse groups of people to come together to generate a common understanding of the nature and underlying dynamics of complex problems and to test out different strategies for more effectively managing them through simulation modeling. Miles is the lead organizer for the annual Innovations in Collaborative Modeling conference at Michigan State University.

Leigh Graves Wolf

Leigh Graves Wolf is teacher-scholar, and her work centers around online education, emerging technologies and relationships mediated by and with technology. She has worked across the educational spectrum, from K12 to higher and lifelong education. She has been a disc jockey, network administrator, teacher, instructional technologist and, now, professor. She believes passionately in collaboration and community and is currently the assistant director of the Hub for Innovation in Learning and Technology, an academic specialist in the Dean's office in the MSU College of Education, and a fixed-term associate professor of Educational Technology at Michigan State University.

Mark Sullivan

Mark Sullivan is a composer and associate professor and director of the computer music studios at the Michigan State University College of Music. His compositions have been performed widely. Over three decades at MSU, he has taught music composition, computer music, and aesthetic theory, and he has written on the relationship between music, movement, and language. He developed and taught courses on the pedagogy of composition, and helped develop two major initiatives on creativity, innovation, and entrepreneurship. During this time, he also created integrated media arts programs for youth, most recently, as a part of a faculty team that helped create a new program centered on developing literacy through songwriting and media composition. As of 2016, he will split his efforts between the College of Music, and the Hub for Innovation in Learning and Technology, working on several projects, including one that integrates art and media composition into STEM education, and another that focuses on cultivating digital media literacy across the curriculum. He received a doctor of musical arts from the University of Illinois at Urbana-Champaign. Sullivan composes for acoustic instruments, with and without the computer, and for both instruments and computer-generated sounds. He specializes in the analysis and performance of contemporary music and in studies that relate music to the other arts and society.
