#### **Kwesi Brookins**

Kwesi Brookins, Ph.D., is associate provost for University Outreach and Engagement and a professor of ecological-community psychology at Michigan State University. He is a former professor of psychology and Africana studies at NC State University. During his time at NC State, he founded the Africana Studies Program and several study abroad programs in Africa, directed the Center for Family and Community Engagement, and was vice provost for University Outreach and Engagement. Dr. Brookins has conducted research with communities across the state of North Carolina and, more recently, led a community-university partnership with Black communities in Southeast Raleigh. He has published several studies on community-based interventions, African American identity development, and the necessity of developing a social and political consciousness for community leadership and activism. In 2018-19, Dr. Brookins was an American Council of Education Fellow, during which he spent a year at Virginia Commonwealth University and visited institutions across the United States and Canada to learn best practices in urban community engagement.

## Desiree Baolian Qin

Desiree Baolian Qin, Ed.D., is an associate professor of human development and family studies at MSU. Her research, funded by the William T. Grant Foundation and the Spencer Foundation, focuses on highlighting nuanced, complex family processes that have been overlooked in quantitative work on Asian immigrant families, especially struggle in parent-child relations, e.g., emotional alienation, parent-child conflicts, communication challenges, and the negative impact of "tiger parenting." Her recent project examines academic and psychosocial adaptation challenges of Chinese international students. Dr. Qin is also interested in decolonizing research methodology, mindfulness, and the science of well-being. Outside her academic work, she enjoys Zen meditation and writing poems and essays that help with healing.

#### Kristina Reitler

Kristina Reitler serves as associate director of employer relations at the Eli Broad College of Business Russell Palmer Career Management Center. She develops and implements engagement strategies to connect students with top employers. In a previous role, Ms. Reitler was a hotel director of sales and provided top-notch event services while mentoring and motivating a diverse group of 12 team members. Her experience in sales has given her a deep understanding of effective communication, marketing strategies, and leadership.

She earned her master's from Michigan State University's Eli Broad College of Business and her bachelor's from the same college's School of Hospitality Business. Her core competencies include guest service leadership, strategic planning, partnership & collaboration, relationship building, and team development.

# **Morgan Shipley**

Morgan Shipley, Ph.D., is the inaugural Foglio Endowed Chair of Spirituality and associate chair for undergraduate studies for the Department of Religious Studies at Michigan State University. Author of *Psychedelic Mysticism: Transforming Consciousness, Religious Experiences, and Voluntary Peasants in Postwar America* (Lexington Books, 2015) and coeditor of *The Silence of Fallout: Nuclear Criticism in a Post-Cold War World* (Cambridge Scholars Publishing, 2013), Dr. Shipley's research explores spirituality and heterodox religious inflections in the United States through a distinctly interdisciplinary perspective, with a particular focus on 1) understanding mystical and esoteric new religions that highlight spirituality as opposed to institutional religiosity, 2) positioning individuals and groups who increasingly identify as spiritual but not religious, and 3) advancing secular spirituality as a distinct way of engaging the world by seeking out more inclusive, virtuous, and responsible ways of being and being together.

#### Emilie Smith

Emilie Smith, Ph.D., is a professor of human development and family studies, the inaugural College of Social Science Distinguished Senior Scholar, and lead of MSU's Youth Equity Project, Thematic Area on Marginalized Youth. Dr. Smith previously served as the Janette McGarity Barber Professor and head of the Department of Human Development and Family Science at the University of Georgia. She is a Fellow of Division 27, Society for Community Research and Action of the American Psychological Association. She has served as an associate editor of the American Journal of Community Psychology, on the editorial board of the Journal of Adolescent Research, and as a consulting editor for numerous other journals.

Dr. Smith has served on the elected Executive Board of the Society for Prevention Research and currently serves on the elected Governing Council of the Society for Research on Child Development. Her work at the local and national levels has demonstrated effective approaches to engaging lower-income ethnic minority families into prevention research using group-based family and community, culturally informed approaches. This is epitomized in her coedited book, *Preventing Youth Violence in a Multicultural Society* (2006, American Psychological Association), as well as in her coedited Special Section on Positive Youth Development in Diverse and Global Contexts in the journal *Child Development*. Her work on racial-ethnic identity and socialization among marginalized youth and social justice approaches to positive youth development is highly cited in the field. Dr. Smith has received over \$20 million in national and foundation funding for her research on promoting positive child and family development, along with numerous local and national awards.

#### William Hart-Davidson

Bill Hart-Davidson earned his Ph.D. in 1999 in rhetoric & composition from Purdue University. He is a professor in the Department of Writing, Rhetoric, and American Cultures, a senior researcher in the Writing, Information, and Digital Experience Research Center, and associate dean for research and graduate education in the College of Arts & Letters. He has published over 100 articles and book chapters and is co-inventor of Eli Review, a software service that supports writing instruction.

## **Joel Berends**


